- (ii) against the post of Programmer at Sr. No. 9, for the existing entry in Column No. 7, the following shall be substituted:

*"By promotion on the basis of seniority-cum-fitness from amongst the Composers having ten years' service as such including five years programming experience in SQL or ASP Net, C. Sharp Net, SQL or Crystal Reporting and Visual Fox Pro.
If none is available by promotion, then by initial recruitment."*

- (iii) against the post of Network System Engineer (BS-17), at Sr. No. 10, for the existing entry in Column No. 5, the following shall be substituted:

"Master's degree (second division or grade-B) in Computer Sciences or Information Technology or four years Bachelors degree (second division or grade-B) in Computer Sciences or Information Technology from a recognized University; or

three years' Bachelor's degree (second division or grade-B) in Computer Sciences or Information Technology from a recognized University with Microsoft or CISCO Certification and three years' experience of Network Administration or trouble shooting.

Note: Preference shall be given to those who have certification in modern IT Tools and technologies in Network System Administration."
