**NOTIFICATION**

**NO.SOR-III(S&GAD)1-12/2004.** In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Directorate General Protocol, Punjab, Service Rules, 2005, the following amendments shall be made:

**AMENDMENTS**

In the said rules, in the Schedule:-

- a) for the existing entry in Column No. 7, against the post of Assistant Protocol, the following shall be substituted:-

*"(i) 75% by initial recruitment; and*

*(ii) 25% by promotion on the basis of seniority-cum-fitness from amongst the Baggage Supervisors of the functional unit having four years regular service as such; and"*

- b) against Sr. No. 10-A, the following new entries in Column No. 1 to 10 shall be inserted.


