**NOTIFICATION**

**No.SOR-III(S&GAD)1-12/2005(P).**-In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to direct that in the Directorate General of Sports, Punjab Service Rules, 2008 the following further amendments shall be made:

**AMENDMENTS**

In the Directorate General of Sports, Punjab Service Rules, 2008, in the Schedule:

- (1) in column 1, for the existing entries, wherever occur, the following shall be substituted:-  
"Youth Affairs, Sports, Archaeology & Tourism Department.";
- (2) at Sr. No. 2, in column 7, for the existing entries, the following shall be substituted:  
"(a) By promotion on the basis of seniority-cum-fitness from amongst the Deputy Directors (Admn), Deputy Directors (Planning & Development), Deputy Directors (Budget & Accounts) and Divisional Sports Officers in the functional unit, having five years' experience as such; or  
(b) if none is available for promotion, by initial recruitment.";
- (3) at Sr. No. 3, in column 3, for the existing entries, the following shall be substituted:  
"Deputy Director (Admn) / Deputy Director (Planning & Development) / Deputy Director (B&A) / Divisional Sports Officer (BS-18).";
- (4) at Sr. No. 6, in column 7, for the existing entries, the following shall be substituted:  
(a) By promotion on the basis of seniority-cum-fitness from amongst Divisional Coaches, in the functional unit, having three years' service as such; or  
(b) if none is available for promotion, by initial recruitment."; and
- (5) at Sr. No. 10, in column 3, for the existing entries, the following shall be substituted:  
"Divisional Coach / Coach Dring Stadium, Bahawalpur.".
