No.SOR-III(S&GAD)1-12/2005(P). In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Directorate General of Sports, Punjab Service Rules, 2008, the further following amendments shall be made:

AMENDMENTS

In the Directorate General of Sports, Punjab Service Rules, 2008, in the Schedule:

at Sr. No. (12) [Electrical Supervisor], in column 7, for the existing entries, the following shall be 1. substituted:

> "By promotion on the basis of seniority-cum-fitness from amongst the Assistant Electrical Supervisors (BS-11), in the functional unit, with two years' regular service as such and who have successfully completed Electrical Supervisor Course or equivalent course from Punjab Technical Education and Vocational Training Authority or any other Government Institute affiliated with that Authority.

If none is available for promotion, by initial recruitment."; and

at Sr. 12.a [Assistant Electrical Supervisor (BS-11)], in column 7, for the existing entries, the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst the Electricians (BS-5) in the functional unit with seven years' regular service as such and who have successfully completed Electrical Supervisor Course or equivalent course from Punjab Technical Education and Vocational Training Authority or any other Government Institute affiliated with that Authority.

If none is available for promotion, by initial recruitment.".
