- Short title and commencement.- (1) These rules may be cited as the District Law
   Officers Service Rules, 2010.
  - (2) These shall come into force at once.
- 2. Method of recruitment.- The method of recruitment, minimum qualification, age limit and other matters related to the posts shall be as given in the Schedule.
- 3. Repeal.- The District Law Officers Appointment Rules, 1977 are hereby repealed.
