NOTIFICATION

No. SOR-III(S&GAD)1-24/2007(P). In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Environment Protection Department Service Rules, 1997, the following amendments shall be made:

AMENDMENTS

In the said rules, in the Schedule:

(1) At Sr. No. 1, in column No. 7, for the existing entry, the following shall be substituted:

"By promotion on the basis of selection on merit from amongst the Deputy Directors, except Deputy Director (Admn), having such minimum length of service for promotion to BS-19 as may, from time to time, be prescribed by the Government."

(2) At Sr. No. 1-A, in column No. 7, for the existing entry, the following shall be substituted:


"By promotion on the basis of selection on merit from amongst Directors, having such minimum length of service for promotion to BS-20 as may, from time to time, be prescribed by the Government."

Note: If none is available for promotion, by initial recruitment or by posting of an APUG or PMS Officer.".

- (3) At. Sr. No. 2:
 - (a) in column No. 5, for the existing entry, the following shall be substituted:

"Ph.D. in Environmental Engineering or Environmental Sciences with M.Sc., B.S or B.Sc. Hons (four years) in Environmental Sciences from a recognized University.

Note: If none is available with required qualification then M. Phil in Environmental Sciences (second division) with M.Sc. B.S. or B.Sc. Hons. (four years) in Environmental Engineering or Sciences from a recognized University with two years' experience in the relevant field."; and



- (b) in column No.7, for the existing entry, the following shall be substituted:
 - "i) 20% by initial recruitment; and
 - 80% by promotion on the ii) basis of seniority-cum-fitness amongst from Assistant District Directors (Field), Officer (Environment) District Officer Deputy (BS-17) (Environment) having five years' experience in the relevant field.".
- (4) At Sr. No.7, in column No.5, for the existing entry, the following shall be substituted:
 - "(i) M.Sc. or B.S (second division) in Chemistry or Bio-Chemistry from a recognized University; or
 - (ii) B.Sc. (second division) in Chemical Engineering from a recognized University.".
- (5) At Sr. No.13, in column No.5, for the existing entry, the following shall be substituted:

"M.Sc. or B.S. (second division) in Chemistry or Bio-Chemistry from a recognized University.".

- (6) At Sr. No.15:
 - (a) in column No.5, for the existing entry, the following shall be substituted:

"B.S. (60% marks) in Environmental Sciences from a recognized University.";

- (b) in column No.7, for the existing entry, the following shall be substituted:
 - "(i) 50% by initial recruitment; and
 - (ii) 50% by promotion on the basis of seniority-cum-fitness from amongst Field Assistants having qualification of F.Sc. (second division) from a recognized Board and ten years' experience in the relevant field.";
- (c) in column No.8, for the existing entry, the following shall be substituted: "21"; and
- (d) in column No.9, for the existing entry, the following shall be substituted:
- (7) After the existing entries at Sr. No. 36, in column Nos.1 to 10, the following new entries at Sr. Nos. 37, 38 and 39 shall be inserted:
