NOTIFICATION

No.SOR-III(S&GAD)1-9/96. In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Headquarters Ministerial Posts Board of Revenue, Punjab Service Rules, 1997, the following amendments shall be made:

AMENDMENTS

In the Headquarters Ministerial Posts Board of Revenue, Punjab Service Rules, 1997, in the Schedule:-

- (a) at Sr. No. 2, in column No. 7, for the existing entry, the following shall be substituted:
- "By promotion on the basis of seniority-cum-fitness from amongst the Assistants in the relevant functional unit having five years' service as such and who have successfully completed four weeks' training from Management and Professional Development Department.";
- (b) at Sr. No. 3, in column No. 7, for the existing entry, the following shall be substituted:
- "By promotion on the basis of seniority-cum-fitness from amongst the Personal Assistants in the relevant functional unit and who have successfully completed six weeks' training from Management and Professional Development Department.";
- (c) at Sr. No. 4, in column No. 7, for the existing entry, the following shall be substituted:
- "By promotion on the basis of seniority-cum-fitness from amongst the Senior Scale Stenographers in the relevant functional unit and who have successfully completed two weeks' training from Management and Professional Development Department.
- If none is available for promotion, by initial recruitment.";
- (d) at Sr. No. 5, in column No. 7, for the existing entry, the following shall be substituted:
- "By promotion on the basis of seniority-cum-fitness from amongst the Stenographers in the relevant functional unit and who have successfully completed two weeks' training from Management and Professional Development Department.
- If none is available for promotion, by initial recruitment.";
- (e) at Sr. No. 6, in column No. 7, for the existing entry, the following shall be substituted:
- "By initial recruitment.
- Note: Successful completion of four weeks' training from Management and Professional Development Department for purposes of confirmation.";

- (f) at Sr. No. 9, in column No. 7 for the existing entry, the following shall be substituted:
- "By promotion on the basis of seniority-cum-fitness from amongst the Junior Clerks in the relevant functional unit having two years' services as such and who have successfully completed two weeks' training from Management and Professional Development Department.";
- (g) at Sr. No. 10, in column No. 7 for the existing entry, the following shall be substituted:
- "(i) 80% by initial recruitment; and
- Note: Successful completion of four weeks' training from Management and Professional Development Department for purposes of confirmation.";
- (ii) 20% by promotion on seniority-cum-fitness basis from amongst the employees of (BS-1) to (BS-4) in the relevant functional unit and who have successfully completed two weeks' training from Management and Professional Development Department."; and
- (h) at Sr. No. 25, in column No. 7 for the existing entry, the following shall be substituted:
- "By initial recruitment.
- Note: Successful completion of four weeks' training from Management and Professional Development Department.


