NOTIFICATION

No.SOR-III-S&GAD)1-26/2012.- In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to make the following amendments in the Punjab Civil Secretariat (Motor Transport Wing) Service Rules 2013, with immediate effect:

AMENDMENTS

In the Punjab Civil Secretariat (Motor Transport Wing) Service Rules 2013, in the Schedule:

1. In column No. 2, under the heading 'Functional Unit', against all serial numbers, for existing entry, the following shall be substituted:

"Motor Transport Wing".

2. At Sr. No. 1, for the post of 'Garage Superintendent (BS-16)', in column Nos. 1 to 10, for existing entries, the following shall be substituted:

3. At Sr. No. 2, for the post of 'Garage Supervisor (BS-11)':
 - (a) in column No. 5, the existing entry shall be omitted;

- (b) in column No. 7, for existing entry, the following shall be substituted:
 "By promotion on the basis of seniority-cum-fitness from amongst Senior Drivers (BS-07) with ten years' service as such and who have successfully completed promotion related training from Punjab Emergency Service Department.";
- (c) in column No. 8, the existing entry shall be omitted;
- (d) in column No. 9, the existing entry shall be omitted; and
- (e) in column No. 10, the existing entry shall be omitted.
4. At Sr. No. 3, for the post of 'Senior Driver (BS-07)':
- (a) in column No. 7, for existing entry, the following shall be substituted:
 "By promotion on the basis of seniority-cum-fitness from amongst Drivers (BS-05) with five years' service as such and who have successfully completed promotion related training from Punjab Emergency Service Department."; and
- (b) in column No. 10, the existing entry shall be omitted.
5. At Sr. No. 4, for the post of 'Head Mechanic (BS-07)':
- (a) in column No. 7, for existing entry, the following shall be substituted:
 "By promotion on the basis of seniority-cum-fitness from amongst Mechanics (BS-06) having three years' service as such."; and
- (b) in column No. 10, the existing entry shall be omitted.
6. At Sr. No. 5, for the post of 'Senior Auto Electrician (BS-07)':
- (a) in column No. 7, for existing entry, the following shall be substituted:
 "By promotion on the basis of seniority-cum-fitness from amongst Auto Electricians (BS-05) having seven years' service as such."; and
- (b) in column No. 10, the existing entry shall be omitted.
7. At Sr. No. 7, for the post of 'Mechanic (BS-06)':
- (a) in column No. 5, the existing entry shall be omitted;
- (b) in column No. 7, for existing entry, the following shall be substituted:
 "By promotion on the basis of seniority-cum-fitness from amongst Assistant Mechanics (BS-

- 05) having seven years' service as such.";
- (c) in column No. 8, the existing entry shall be omitted;
- (d) in column No. 9, the existing entry shall be omitted; and
- (e) in column No. 10, the existing entry shall be omitted.
8. At Sr. No. 8, for the post of 'Assistant Mechanic (BS-05)':
- (a) in column No. 5, for existing entry, the following shall be substituted:
- "(i) Secondary School Certificate (second division) from a recognized Board;
- (ii) one year Certificate in the relevant field from TEVTA or any of its recognized institute;
- (iii) Valid Light Transport Vehicle driving license; and
- (iv) four years' practical work experience from any reputed auto mobile workshop.
- Preference shall be given to those who have experience with 3S Workshops of Toyota, Honda, Suzuki etc.";
- (b) in column No. 9, for existing entry, the following shall be substituted:
- "25"; and
- (c) in column No. 10, the existing entry shall be omitted.
9. At Sr. No. 9, for the post of 'Auto Electrician (BS-05)':
- (a) in column No. 5, for existing entry, the following shall be substituted:
- "(i) Secondary School Certificate (second division) from a recognized Board;
- (ii) one year Certificate in the relevant field from TEVTA or any of its recognized institute;
- (iii) valid Light Transport Vehicle driving license; and
- (iv) four years' practical work experience from any reputed auto mobile workshop.
- Preference shall be given to those who have experience with 3S Workshops of Toyota, Honda, Suzuki etc."; and
- (b) in column No. 10, the existing entry shall be omitted.
10. At Sr. No. 10, for the post of 'Driver (BS-04)':

- (a) in column No. 3, for existing entry, the following shall be substituted:
"Driver (BS-05)";
- (b) in column No. 5, for existing entry, the following shall be substituted:
"(i) Secondary School Certificate (second division) from a recognized Board;
(ii) valid Light Transport Vehicle driving license with five years' experience; and
(iii) valid Public Service Vehicle driving license.";
- (c) in column No. 6, for existing entry, the following shall be substituted:
"As prescribed for initial recruitment.";
- (d) in column No. 7, for existing entry, the following shall be substituted:
"i) 97% by initial recruitment:
(a) 90% on the basis of Light Transport Vehicle driving license; and
(b) 07% on the basis of Public Service Vehicle driving license; and
ii) 03% by promotion on the basis of seniority-cum-fitness from amongst Staff Car Cleaners (BS-01) with five years' service as such and who have successfully completed promotion related training from Punjab Emergency Service Department.";
and
- (e) in column No. 10, for existing entry, the following shall be substituted:
"Post induction training from Punjab Emergency Service Department.".
