**NOTIFICATION**

**No.SOR-III(S&GAD)1-19/2004.-** In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to make the following amendments in the Chief Minister's Secretariat Household Staff Service Rules 2012, with immediate effect:

**AMENDMENTS**


In the Chief Minister's Secretariat Household Staff Service Rules 2012, in the Schedule:

1. At Sr. No. 3, for the post of 'Comptroller (BS-18)', in column No. 7, for existing entry, the following shall be substituted:

*"By promotion on the basis of seniority-cum-fitness from amongst the Deputy Comptrollers (BS-17) who have five years' regular service in the functional unit and who have successfully completed promotion related training from Management and Professional Development Department or Tourism and Hotel Management Training Institute.  
If none is available by promotion then by initial recruitment."*

2. At Sr. No. 8, for the post of 'Deputy Comptroller (BS-17)', in column No. 7, for existing entry, the following shall be substituted:

*"By promotion on the basis of seniority-cum-fitness from amongst the Assistant Comptrollers (BS-16) who have four years' regular service in the functional unit and who have successfully completed promotion related training from Management and Professional Development Department or Tourism and Hotel Management Training Institute.  
If none is available by promotion then by initial recruitment."*
