**NOTIFICATION**

**No.SOR-III(S&GAD)1-16/2006.-** In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to make the following amendments in the Punjab Provincial Management Service Rules, 2004, with immediate effect:

**AMENDMENTS**

**In the Punjab Provincial Management Service Rules, 2004:**

1. In rule 2, after clause f), the following shall be inserted:
  - "ff) "induction" means the appointment from amongst Tehsildars, Superintendents and Private Secretaries into PMS through Departmental Induction Committee."
2. In Schedule-I, against the post of 'PMS (BS-17)':
  - (a) in column No. 7, for clause (2), the following shall be substituted:
 

"(2) 45% to be filled by induction as under:

    - (a) 22.5% on the basis of seniority-cum-fitness from amongst Tehsildars who are Graduates with five years' service as Tehsildar and have successfully completed Pre-Induction Training Course from Management and Professional Development Department. In case of promotee Tehsildars, the condition of five years' service shall not be applicable; and
    - (b) 22.5% on the basis of seniority-cum-fitness from amongst Superintendents and Private Secretaries at the ratio of 50:50 respectively who are Graduates and have successfully completed Pre-Induction Training Course from Management and Professional Development Department."; and
  - (b) in column No. 10, "Note" shall be omitted.
