NOTIFICATION

No.SOR-III(S&GAD)1-10/2007. In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to make the following amendments in the Punjab Social Welfare and Bait-ul-Maal Department (Directorate) Service Rules, 2009, with immediate effect:

AMENDMENTS

In the Punjab Social Welfare and Bait-ul-Maal Department (Directorate) Service Rules, 2009, in the Schedule:

- at Sr. No.4, for the post of 'District Officer (SW)/Deputy Director (BS-18)': 1.
 - (a) in column No. 3, for existing entry, the following shall be substituted: "Deputy Director (BS-18)"; and
 - (b) in column No. 7, for existing entry, the following shall be substituted.
 - "i.90% by promotion on the basis of seniority cum fitness from amongst the Social Welfare Officers / Medical Social Officers / Superintendents (Dar-ul-Aman) with 5 years service as such.
 - ii.10% by initial recruitment.".
- at Sr. No. 11, for the post of 'Social Welfare Officer / Medical Social Officer / 2. Deputy District Officer (SW)', in column No. 3, for existing entry, the following shall be substituted:

Officer/ Officer/Medical Social "Social Welfare COVERNMENT OF FICER (R-III)
