No.SOR-III(S&GAD)1-10/2007. In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to make the following amendments in the Punjab Social Welfare and Bait-ul-Maal Department (Directorate) Service Rules, 2009, with immediate effect:

AMENDMENTS

In the Punjab Social Welfare and Bait-ul-Maal Department (Directorate) Service Rules, 2009, in the Schedule:

1. at Sr. No.4, for the post of 'District Officer (SW)/Deputy Director (BS-18)':
 - (a) in column No. 3, for existing entry, the following shall be substituted:
"Deputy Director (BS-18)"; and
 - (b) in column No. 7, for existing entry, the following shall be substituted.


"i.90% by promotion on the basis of seniority cum fitness from amongst the Social Welfare Officers / Medical Social Officers / Superintendents (Dar-ul-Aman) with 5 years service as such.
ii.10% by initial recruitment."
2. at Sr. No. 11, for the post of 'Social Welfare Officer / Medical Social Officer / Deputy District Officer (SW)', in column No. 3, for existing entry, the following shall be substituted:
"Social Welfare Officer/Medical Social Officer/
Superintendent (Dar-ul-Aman) (BS-17)".
