NOTIFICATION

No. SOR-III(S&GAD)1-10/2008: In exercise of the powers conferred upon him under Section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), the Governor of the Punjab is pleased to direct that in the Punjab Anti-Corruption Establishment Service Rules, 2007, the following amendment shall be made, namely:-

AMENDMENT

In the schedule against Sr. No. 15, for the existing entries in Column No. 3 and Column No. 7, the following shall be substituted:-

	Assistant Director (Admn/Complaints/Monitoring/ SO(D)/Admn Officer.	By promotion on seniority-cum-fitness basis from amongst . . Superintendents and Personal Assistants/Senior Scale Stenographers at the ratio of 55:45 having minimum service of 03 years as such. In case the candidate after completion of three years service as Senior Scale Stenographer is promoted against the post of P.A., then no further condition of service as such will be imposed on him for promotion as Assistant Director. Note: The existing Admn Officers who are non-graduate would be required to get the degree of B.A./B.Sc within 4 years.


