NOTIFICATION

No.SOR-III(S&GAD)1-10/2008(P). In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Anti-Corruption Establishment Service Rules, 2007, the following amendments shall be made:

AMENDMENTS

In the said Rules, in the Schedule, at Sr. No. 11, against the post of Deputy Director (Legal/Prosecution), for the existing entry in Column No. 7, the following shall be substituted:

- "(i) 50% by posting from Law/Prosecution Departments of an officer of the rank of District Attorney or Deputy District Attorney/District Public Prosecutor or Deputy District Public Prosecutor with minimum five years service as Law Officer or Prosecutor; and
- (ii) 50% by promotion from amongst Assistant Directors (Legal/Prosecution) on seniority-cum-fitness basis with minimum five years service as such.

Note: If no suitable person is available for promotion, then by posting of an officer from Law / Prosecution Departments."


