NOTIFICATION

No.SOR-III(S&GAD)1-10/08(PII). In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to direct that in the Punjab Anti-Corruption Establishment Service Rules, 2007, the following further amendment shall be made:

AMENDMENT

In the Punjab Anti-Corruption Establishment Service Rules, 2007, in the schedule, the entry in column No. 7 against the post of Deputy Director (Technical) / Technical Officer (BS-18) shall be substituted as under:

- "(i) 60% by posting of an officer of the grade of XEN from any Engineering Department of Government of the Punjab.
If none is available by posting, then by transfer on permanent basis from any Engineering Department Government of the Punjab.
- (ii) 20% by promotion on seniority-cum-fitness basis from amongst the Assistant Directors (Technical) with minimum five years' service.
- (iii) 20% by initial recruitment through Punjab Public Service Commission.
If no suitable officer is available by promotion or through direct recruitment, then by posting from any Engineering Department of Government of the Punjab with minimum qualification as prescribed."
