## NOTIFICATION

No.SOR-III(S\&GAD)1-3/2015. In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Communication and Works Department (Architectural Posts) Recruitment Rules, 1988, the following amendments shall be made:

## AMENDMENTS

In the said rules, in the Schedule:
(1) at Sr. No. 1 - Chief Architect (BS-20):
(a) in column No. 7, for the existing entry, the following shall be substituted:
"(i) By promotion on the basis of selection on merit from amongst Directors (Architecture) with seventeen years' service in BS-17 and above, or twelve years' service in BS-18 and above, or five years' service in BS-19 in case of direct recruitment having qualifications prescribed for initial recruitment to the post of Assistant Director (Architecture) and registered with Pakistan Council of Architects and Town Planners; and
(ii) successful completion of four weeks' inservice Training Course from Government Engineering Academy Punjab, Lahore."; and
(b) in column No. 10, the following new entry shall be inserted:
"As prescribed under the Punjab Civil Servants (Appointment \& Conditions of Service) Rules, 1974.";
(2) at Sr. No. 2 - Director Architecture (BS-19):
(a) in column No. 7, for the existing entry, the following shall be substituted:
"(i) By selection on merit from amongst Deputy Directors (Architecture) having Bachelor's degree in Architecture or equivalent qualifications and twelve years' service in the functional unit in BS-17 and above, or
seven years' service for those recruited initially to a post carrying BS-18 and registered with Pakistan Council of Architects and Town Planners; and
(i) the successful completion of six weeks' inservice Training Course from Government Engineering Academy Punjab, Lahore."; and
(b) in column No. 10, the following new entry shall be inserted:
"As prescribed under the Punjab Civil Servants (Appointment \& Conditions of Service) Rules, 1974.";
(3) at Sr. No. 3 - Deputy Director Architecture (BS-18):
(a) in column No. 7, for the existing entry, the following shall be substituted:
"(i) 20\% by initial recruitment; and
(ii) $80 \%$ by promotion on the basis of seniority-cum-fitness from amongst Assistant Directors Architecture (BS-17) with five years' service in the functional unit and possessing:
(a) Bachelor's degree in Architecture; or
(b) Diploma in Architecture (five years' full time course) from a recognized University or institution and registered with Pakistan Council of Architects and Town Planners; and
(iii) successful completion of eight weeks' inservice Training Course from Government Engineering Academy Punjab, Lahore."; and
(b) in column No. 10, the following new entry shall be inserted:
"Successful completion of four months' post induction Training Course from Government Engineering Academy Punjab, Lahore."; and
(4) at Sr. No. 4 - Assistant Director Architecture (BS-17):
(a) in column No. 7, for the existing entry, the following shall be substituted:
"(i) 75\% by initial recruitment;
(ii) $05 \%$ by promotion on the basis of seniority-cum-fitness from amongst the Architectural Assistants who possess the qualifications prescribed for initial recruitment; and
(iii) $20 \%$ by promotion on the basis of seniority-cum-fitness from amongst Chief Draftsmen and Architectural Assistants possessing three years' Diploma (DAE) from a recognized Institute with five years' service as Architectural Assistant or Chief Draftsman in the Architecture Department, Punjab or three years' certificate of Senior Architectural Draftsman Course from a recognized Institute with five years' service as Architectural Assistant or Chief Draftsman in the Architecture Department, Punjab.

If none is available for promotion then by initial recruitment."; and
(b) in column No. 10, the following new entry shall be inserted:
"Successful completion of four months' post induction Training Course from Government Engineering Academy Punjab, Lahore.".
