"who have successfully completed in-service training for senior Engineers at Government Engineering Academy, Punjab, Lahore."

6. In the Schedule, in column No. 3, after the words "Executive Engineer", and before the full stop, the following shall be added:-

"Deputy Director/District Officer"

7. In the Schedule, against the post "Executive Engineer" in column No.3, the following shall be added, in column No. 7, after the words "Pakistan Engineering Council" and before the full stop:-

"who have successfully completed in-service training for junior Engineers at Government Engineering Academy, Punjab, Lahore."

8. In the Schedule, against the post "Assistant Engineer" in column No.3, after the words "Assistant Engineer" and before the full stop, the following shall be added:-

"Sub Divisional Officer/ Assistant Director/ Deputy District Officer".
