In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Communication and Works Department (Engineering Posts Qualifications and Conditions for Recruitment) Rules, 1985, the following further amendments shall be made:

AMENDMENTS

In the Punjab Communication and Works Department (Engineering Posts Qualifications and Conditions for Recruitment) Rules, 1985, in the Schedule, in column 3:

- (a) for the expression "Chief Engineer/EDO (Works and Services), City District Government (BS-20)", the expression "Chief Engineer (BS-20)" shall be substituted;
- (b) for the expression "Superintending Engineer/Director/EDO (Works and Services)", the expression "Superintending Engineer/Director (BS-19)" shall be substituted;
- (c) for the expression "Executive Engineer/Deputy Director/District Officer (BS-18)", the expression "Executive Engineer/Deputy Director (BS-18)" shall be substituted; and
- (d) for the expression "Assistant Engineer/Sub-Divisional Officer/Assistant Director/Deputy District Officer", the expression "Assistant Engineer/Sub-Divisional Officer/Assistant Director (BS-17)" shall be substituted.
