1. Short title and commencement:-

(i) These rules may be called, the Punjab District Monitoring Officer (Ministerial Staff) Service Rules, 2005.

(ii) They shall come into force at once.

2. Method of Recruitment and eligibility:-

(1) The method of recruitment, minimum qualification, age limit and other matters related thereto for the posts shall be as given in the schedule annexed.


