NOTIFICATION

No.SOR-III(S&GAD)1-10/2013. In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Environmental Tribunal (Miscellaneous Posts) Service Rules, 2014, the following amendments shall be made:-

AMENDMENTS

In the Punjab Environmental Tribunal (Miscellaneous Posts) Service Rules, 2014, in the Schedule:

- (1)at Sr. No. 1, for the existing entries in column 7, the following shall be substituted: "By posting of an officer of PAS/PMS/Environment Protection Agency (EPA).";
- at Sr. No. 2, for the existing entries in column 7, the following shall be substituted: (2)
 - "By promotion on the basis of seniority-cum-fitness from amongst the Senior Scale Stenographers working in the functional unit having five years' regular service as such and who have successfully completed four weeks' training at Management and Professional Development Department or any other training institute as determined by the administrative department.
 - If none is available for promotion, by posting from Services and General Administration Department (S&GAD) or Environment Protection Agency (EPA).";
- at Sr. No. 3, for the existing entries in column 7, the following shall be substituted: (3)
 - "By promotion on the basis of seniority-cum-fitness from amongst the Stenographers working in the functional unit having four years' regular service as such and w :o have successfully completed two weeks' training at Management and Professional Development Department or any other training institute as determined by the administrative department.
 - If none is available for promotion, by posting from Services and General Administration Department (S&GAD) or Environment Protection Agency (EPA).";
- at Sr. No. 5, for the existing entries in column 7, the following shall be substituted: (4)
 - "(i) 50% by promotion on the basis of seniority-cum-fitness from amongst the Senior Clerks working in the functional unit having four years' regular service as such and who have successfully completed two weeks' training at Management and Professional Development Department or any other training institute as determined by the administrative department; and
 - 50% by initial recruitment. (ii)

If none is available for promotion, by posting from Services and General Administration Department (S&GAD) or Environment Protection Agency (EPA)."; and at Sr. No. 6, for the existing entries in column 7, the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst the Junior Clerks working in the functional unit having four years' regular service as such and who have successfully completed two weeks' training at Management and Professional Development Department or any other training institute as determined by the administrative department.

If none is available for promotion, by posting from Services and General Administration Department (S&GAD) or Environment Protection Agency (EPA).". SECTION CHICER (R-90)
