NOTIFICATION

No.SOR-III(S&GAD)1-9/2008(PI). In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Fisheries Department Service Rules, 2011, the following amendments shall be made:

AMENDMENTS

In the Punjab Fisheries Department Service Rules, 2011:

(1) in the Schedule in column No. 7:

PRIMENT OF THE PUNIAR

(i) at Sr. No. 46 (Administrative Officer BS-17), the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst the Superintendents having five years' service in their respective functional units at the (Headquarter/Director General Level, Directorates / Regional Level) and who have successfully undertaken one month training from Fisheries Research and Training Institute.";

(ii) at Sr. No. 47 (Superintendent BS-17), the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst the Assistants and the Senior Scale Stenographers having three years' service in their respective functional units at the (Headquarter/Director General Level, Directorates/Regional Level) and who have successfully undertaken three weeks training from Fisheries Research and Training Institute.";

(iii) at Sr. No. 48 (Senior Scale Stenographer BS-16), the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst the Stenographers having three years' service in their respective functional units at the (Headquarter/Director General Level, Directorates/Regional Level) and who have successfully undertaken two weeks training from Fisheries Research and Training Institute.";

(iv) at Sr. No. 49 (Assistant BS-16), the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst the Senior Clerks having three years' service in their respective functional units at the (Headquarter/Director General Level, Directorates/Regional Level) and who have successfully undertaken two weeks training from Fisheries Research and Training Institute."; and

(v) at Sr. No. 51 (Senior Clerk BS-14), the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst the Junior Clerks having two years' service in their respective functional units at the (Headquarter/Director General Level, Directorates/Regional Level) and who have successfully undertaken two weeks training from Fisheries Research and Training Institute.".

(2) at Sr. No. 52, for the existing entries in column Nos. 1 to 10, the following shall be substituted:
