In exercise of the powers conferred on him by Section 23 of the Punjab Civil Servants, Act, 1974 and in supersession of this Department Notification No: SO7.III-1-32/71, dated 16.4.1976, the Governor of the Punjab is pleased to direct that in the Punjab Forest Department (Ministerial/Executive Posts) Recruitment Rules, 1979, the following amendments shall be made, namely:-

A M E N D M E N T S.

In the Schedule

- I. the entries against serial No: 28 shall be deleted;
- II. after serial No: 26, under the functional unit 'Forestry (Executive)' the existing entries at serial No: 27 & 29 shall be re-numbered as 33-34 and the following new entries at serial No: 27 to 32 shall be inserted in columns 3 to 10 :-

- (b) 40% by promotion from among the existing Deputy Rangers/Foresters with 10 years' experience as such.


