In exercise of the powers conferred on him by section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), the Governor of the Punjab is pleased to direct that in the Punjab Forest Department (Ministerial/Executive Posts) Recruitment Rules, 1979, the following further amendment shall be made namely:-

AMENDMENT

In the schedule the existing entries against serial No.5 shall be substituted as under : -

5. Superintendent.	Chief Conservator of Forests concerned.	-	..	By promotion on seniority cum-fitness basis from amongst Senior Scale Stenographers/Stenographons and Assistants at 1:2 ratio respectively as under :- i) Assistants with 5 years service as such having passed the departmental examination prescribed by the Department with 2 years experience in Forest Accounts. ii) Senior Scale Stenographers/Stenographons with 5 years service as such who have passed the Departmental examination prescribed for Assistants.			

NOTE: Senior Scale Stenographer would first be promoted and in case no Senior Scale Stenographer is available only then Stenographer would be eligible for promotion to the post of Superintendent.
