## NOTIFICATION

**No.SOR-III(S&GAD)1-3/2002(P).** In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Forest Department (Ministerial / Executive Posts) Recruitment Rules, 1979, the following further amendments shall be made:

## **AMENDMENTS**

In the Punjab Forest Department (Ministerial / Executive Posts) Recruitment Rules, 1979, in the Schedule, at Sr. No. 27:

- (a) in column 4, for the word "Government", the words "Chief Minister", shall be substituted; and
- (b) in column 7, for the existing entries, the following shall be substituted:

"By promotion on the basis of selection-on-merit from amongst the Conservators of Forest having seventeen years' service in BS-17 and above and who have successfully completed twelve weeks Public Policy and Management course from Management and Professional Development Department or such other institution as may be determined.".
