**NOTIFICATION**

**No.SOR-III(S&GAD)1-32/2021.-** In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to make the following amendments in the Punjab Forestry and Wildlife (Wildlife Executive) Service Rules, 1978, with immediate effect:

**AMENDMENTS**

In **the Punjab Forestry and Wildlife (Wildlife Executive) Service Rules, 1978**, in the Schedule:-

(1) at Sr. No. 5, for the post of 'Assistant Director Wildlife (BS-17)':

(a) in column No. 5, for existing entry, the following shall be substituted:

"M.Sc. (first division) or BS (CGPA 3.5) in Zoology or Wildlife Management from a university recognized by Higher Education Commission.";

(b) in column No. 6, the following shall be inserted:

"Bachelor's degree (second division) from a university recognized by Higher Education Commission."; and

(c) in column No. 7, for existing entry, the following shall be substituted:

"i) 60% by initial recruitment; and

ii) 40% by promotion on seniority-cum-fitness basis from amongst Wildlife Supervisors (BS-15) having five years' service as such and who have successfully completed promotion related training from Punjab Wildlife Research Centre, Gatwala, Faisalabad for promotion in BS-17."; and

(2) at Sr. No. 13, for the post 'District Wildlife Officer (BS-16)', in column

Nos. 1 to 10, the existing entries shall be omitted.
