NOTIFICATION

No.SOR-III(S&GAD)1-32/2021.- In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to make the following amendments in the Punjab Forestry and Wildlife (Wildlife Executive) Service Rules, 1978, with immediate effect:

AMENDMENTS

In the Punjab Forestry and Wildlife (Wildlife Executive) Service Rules, 1978, in the Schedule:-

- (1) at Sr. No. 5, for the post of 'Assistant Director Wildlife (BS-17)':
 - (a) in column No. 5, for existing entry, the following shall be substituted: "M.Sc. (first division) or BS (CGPA 3.5) in Zoology or Wildlife Management from a university recognized by Higher Education Commission.";
 - (b) in column No. 6, the following shall be inserted: "Bachelor's degree (second division) from a university recognized by Higher Education Commission."; and
 - (c) in column No. 7, for existing entry, the following shall be substituted: "i) 60% by initial recruitment; and
 - ii) 40% by promotion on seniority-cum-fitness basis from amongst Wildlife Supervisors (BS-15) having five years' service as such and who have successfully completed promotion related training from Punjab Wildlife Research Centre, Gatwala, Faisalabad for promotion in BS-17."; and
- GOVERNMENT OF THE PUNJAB (2) at Sr. No. 13, for the post 'District Wildlife Officer (BS-16)', in column Nos. 1 to 10, the existing entries shall be omitted.
