 - (b) a speed of 100 words per minute in English Shorthand and 40 words per minute in English Typewriting.

By promotion from among 18 the existing incumbents of the posts of Stenotypists who qualify the test with a minimum speed of 100 words per minute in shorthand and 40 words per minute in English Typewriting. If none is available by promotion then by initial recruitment.
