In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that following amendments shall be made in the Punjab Government VIP Flight (Technical Posts) Recruitment Rules 2015:

AMENDMENTS

In the Punjab Government VIP Flight (Technical Posts) Recruitment Rules 2015, in the Schedule:

- (a) at Sr. No. 1, in column 5, for the existing entries the following shall be substituted:
 "(i) Valid Air Transport Pilot License (ATPL); and
 (ii) experience of 3000 flying hours out of which 2000 flying hour should be on twin engine Jet Aircraft and 500 flying hours on turbo prop."; and
 (b) after Sr. No. 1, a new entry at Sr. No. 1A shall be inserted:
