**NOTIFICATION**

**No. SOR-III(S&GAD)2-17/83(PI)** In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), the Governor of the Punjab is pleased to direct that in the Punjab Judicial Service Rules, 1994, the following further amendments shall be made:-

**AMENDMENTS:**

In the said rules, in rule 8, for sub-rule (2), the following shall be substituted:

" (2) A person shall not be confirmed in the service after appointment unless

he has:-

- (i) in case of Civil Judge-cum-Judicial Magistrate undergone pre-service training for at least six months or for such extended period as may be directed by the Chief Justice;
- (ii) in case of Additional District & Sessions Judge whether appointed on promotion or through initial recruitment, undergone a pre-service training for four months or for such extended period as may be directed by the Chief Justice; and
- (iii) passed the examination in the subjects and with the grades as may be prescribed."
