AMENDMENT

In the said rules, in Schedule-I, against the post of PMS (BS-17), in column No.6, in serial No.2, paragraph (b) shall be substituted as under:

"(b) 20% from amongst the Superintendents and Private Secretaries on seniority-cum-fitness basis, who are graduates in the ratio of 50:50, respectively."


