**NOTIFICATION**

**No.SOR-III(S&GAD)1-24/2021.-** In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*) Governor of the Punjab is pleased to make the following amendments in the Punjab Population Welfare Department Service Rules, 2009, with immediate effect:

**AMENDMENTS**

In the Punjab Population Welfare Department Service Rules, 2009, in the Schedule, under heading "TECHNICAL CADRE", at Sr. No. 38, for the post of 'Family Welfare Worker (BS-9)':

- (1) in column No. 5, for existing entry, the following shall be substituted:
- "(i) (a) Secondary School Certificate with Science (second division) from a recognized Board; and  
(b) qualified PNC License for Family Welfare Workers; or  
(ii) (a) Secondary School Certificate from a recognized Board;  
(b) certificate of training for Family Welfare Workers from Regional Training Institutes of Population Welfare Department, Punjab; and  
(c) three years' experience of working as Family Welfare Workers in the project; or  
(iii) (a) Secondary School Certificate from a recognized Board;  
(b) LHV course from recognized institution; and  
(c) three years' experience as Family Welfare Worker in the project.

**Note:** Provided that the candidate who is appointed under sub-clause (ii) and (iii) shall get himself registered, within three years of his appointment, with the Pakistan Nursing Council."; and

in column No. 10, the existing entry shall be omitted.
