## NOTIFICATION

No.SOR-III(S&GAD)1-24/2021.- In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974) Governor of the Punjab is pleased to make the following amendments in the Punjab Population Welfare Department Service Rules, 2009, with immediate effect:

## **AMENDMENTS**

In the Punjab Population Welfare Department Service Rules, 2009, in the Schedule, under heading "TECHNICAL CADRE", at Sr. No. 38, for the post of 'Family Welfare Worker (BS-9)':

- (1) in column No. 5, for existing entry, the following shall be substituted:
  - "(i) Secondary School Certificate with Science (second (a) division) from a recognized Board; and
    - qualified PNC License for Family Welfare Workers; (b) or
  - Secondary School Certificate from a recognized (ii) (a) Board;
    - (b) certificate of training for Family Welfare Workers from Regional Training Institutes of Population Welfare Department, Punjab; and
    - three years' experience of working as Family (c) Welfare Workers in the project; or
  - Secondary School Certificate from a recognized (iii) (a) Board;
    - LHV course from recognized institution; and (b)
    - three years' experience as Family Welfare Worker (c) in the project.

Note: Provided that the candidate who is appointed under subclause (ii) and (iii) shall get himself registered, within three years SUVERNMENT OF THE PUNIAR of his appointment, with the Pakistan Nursing Council."; and

in column No. 10, the existing entry shall be omitted.
