No. SOR-III- 2-2/85. . In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974, (VIII of 1974), the Governor of the Punjab is pleased to direct that in the Punjab Revenue Department (Revenue Administration Posts) Rules, 1990, the following (further) amendments shall be made, namely:-

AMENDMENTS.

In the Schedule-

I. Against Serial No. 1 in column 7 for the existing entries the following shall be substituted:-

1. 30% by initial recruitment on the recommendation of the Punjab Public Service Commission based on the result of competitive examination conducted by it in accordance with the syllabus prescribed under the West Pakistan Civil Service (Executive Branch) Rules, 1954.
2.
 - a) 53% by promotion on seniority cum fitness basis from amongst ~~Najib~~ Tehsildars in the functional unit.
 - b) 17% by ^{promotion through} selection on merit from amongst subordinate service as under:-
 - i) Assistants and Sr. scale Stenographers in the office of Board of Revenue and other Offices subordinate to the Board with 3 year experience as such.
 - ii) Head Vernacular Clerks in the offices of Divisional Commissioners and Deputy Commissioners who have 3 years experience as such.
 - iii) Colonies Head Clerks in the office of Deputy Commissioners who have 3 years experience as such.
 - iv) Inspectors of Stamps, Board of Revenue who have 3 years experience as such.
 - v) Revenue Auditors of Board of Revenue who have 3 years experience as such.
 - vi) Superintendents in the office of Board of Revenue and other offices subordinate to the Board.

Note:- 1) They shall be deemed to be the members of the same functional unit for the purposes of promotion to the post of Tehsildar.

Note:- 2) Selection of Sr. Scale Stenographers shall not exceed 20% of the quota fixed for subordinate services.

I. Against Serial No. 2 in column 7 for the existing entries, the following shall be substituted:-

1. 50% by initial recruitment.
2. a) 38% by promotion on seniority cum fitness basis from amongst Kanungos in the division with at least 3 years experience as such.
b) promotion through 12% by selection on merit from amongst subordinate services as under:-
 - i) Assistants, Stenographers and Sr. Clerks of Revenue Department in the division who have three years experience as such.
 - ii) Assistants, Stenographers and Sr. Clerks in the office of Board of Revenue, Punjab, Directorate of Land Records, Punjab and Punjab Revenue Academy who have three years experience as such.

Note:- 1) They shall be deemed to be the members of the same functional unit for the purposes of promotion to the post of Naib Tehsildar.

Note:- 2) Selection from Stenographers shall not exceed 20% of the quota fixed for subordinate services.


