NOTIFICATION

No. SOR-III(S&GAD)2-30/2006. In exercise of the powers conferred upon him under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), the Governor of the Punjab is pleased to direct that in partial modification of this department's notification No.SOR-III-1-21/85 dated 5th December 1986, in the various sets of Service/Recruitment Rules, hereinafter referred to as the rules in their application to province of the Punjab, the following further amendments shall be made:

AMENDMENTS

In the schedule, against the post of Stenographer (BS-12) in column No.5, the following shall be substituted:

- (i) Intermediate or equivalent qualification from a recognized Board.
- (ii) A speed of 70 w.p.m. in shorthand in English and 35 w.p.m. typing speed on typewriter or on computer.
- (iii) Computer literate in M.S. Office.

Note:- Preference shall be given to the candidates who know Urdu Shorthand at a speed of 60 w.p.m. and typewriting at a speed of 25 w.p.m.


