In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to direct that in the Punjab Social Welfare, Women Development and Bait-ul-Mal Department (Directorate) Service Rules, 2009, the following further amendments shall be made:

AMENDMENTS

In the Punjab Social Welfare, Women Development and Bait –ul-Mal Department (Directorate) Service Rules, 2009:

- (1) in rule 1, for clause a) the following shall be substituted:
 - "a) These rules may be cited as **the Punjab Social Welfare and Bait-ul-Maal Department (Directorate) Service Rules, 2009.**";
- (2) in the Schedule:
 - (a) in column 1, for the existing entries, wherever occur, the following shall be substituted:

 - (b) in column 2, for the existing entries, wherever occur, the following shall be substituted:
"Directorate General, Social Welfare and Bait-ul-Maal Department"; and
