NOTIFICATION

No. SOR-III(S&GAD)1-17/2007(PI). In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Special Education Department (Directorate of Special Education) Service Rules, 2006, the following amendments shall be made:

AMENDMENTS

In the said rules, in the Schedule:

- (1) at Sr. No. 38(b)-"Psychologist (BS-17)", in column No.5, for the existing entry, the following shall be substituted:

"M.Sc. in Psychology or Applied Psychology (second division or grade-C) from a recognized University.";
- (2) at Sr. No. 49-"Senior Scale Stenographer":
 - (a) in column No. 3, for the existing entry, the following shall be substituted:


"Senior Scale Stenographer (BS-16)";
 - (b) in column No. 4, for the existing entry, the following shall be substituted:

"Administrative Secretary";
 - (c) in column No. 5, for the existing entry, the following shall be substituted:

"Graduate (second division or grade-C) from a recognized University and having a speed of 100 words per minute of shorthand in English and 40 words per minute of typing on computer."; and
 - (d) in column No. 7, for the existing entry, the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst the Stenographers. (BS-14) in the functional unit.
If none is available for promotion then by initial recruitment."; and
- (3) at Sr. No. 58-"Audiometrist (BS-12)":
 - (a) in column No. 5, for the existing entry, the following shall be substituted:

"B.Sc. with Physics (second division or grade-C) from a recognized University with one year experience in the relevant field."; and

(b) in column No. 7, for the existing entry, the following shall be substituted:

- "(i) 90% by initial recruitment; and
(ii) 10% by promotion on the basis of seniority-cum-fitness from amongst Technicians working in audiological clinics of Special Education Institutes of Hearing Impaired with five years' service as such.

If none is available for promotion then by initial recruitment."
