NOTIFICATION

No.SOR-III(S&GAD)1-29/2002.- In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to make the following amendments in the Punjab Energy Department (Power Wing) Service Rules 2013, with immediate effect:

AMENDMENTS

In the Punjab Energy Department (Power Wing) Service Rules 2013, in the Schedule:

1. At Sr. No. 2, for the post of 'Director Technical (BS-19)', in column No. 7, for existing entry, the following shall be substituted:

"By promotion on the basis of selection-on-merit from amongst Electric Inspectors / Deputy Directors (BS-18) in the functional unit who have:

- (i) (a) seven years' service in BS-18, in case of initial recruitment in BS-18; or
 - (b) twelve years' service in BS-17 and above, in case of initial recruitment in BS-17; and
- (ii) successfully completed promotion related training from BS-18 to BS-19 at Government Engineering Academy, Lahore.

If none is available for promotion, then by posting of a suitable officer or by initial recruitment.".

2. For entry at Sr. No. 6, in column Nos. 1 to 10, the following shall be substituted:
